Processing:	The surfaces shall be firm, sustainable, clean, dry and free of separating substances (fats, oils, etc.). The surfaces shall not contain substances containing tar, as otherwise the adhesion is reduced. The application on fresh bitumen is not recommended for the same reasons. On old bitumen an adhesion can be reached of maximum 0.45 N/mm <sup>2</sup> , as long as the surface is free of grease. For cleaning of surfaces we recommend using of <i>FIX-O-FLEX HAFTGRUND</i> . For high sucking groundings like weathered concrete, gypsum, aerated concrete etc. the use of <i>FIX-O-FLEX PRIMER</i> is recommended.		



	The adhesion on hard-to-bond plastics such as PE or PP (polyolefine) should be tested before beginning. When applying on coated surfaces a preliminary test of compatibility is necessary.
	Opened containers should be used up as soon as possible.
	The full hardening time depends on the humidity and temperature. By increasing the temperature and humidity the full hardening time can be reduced.
